EXPORT PROMOTION ACTIVITIES 2023-24

The details of events participation organised by the Council during 2023-24 are furnished below:

A. International events - Abroad:

1. Hometextiles Sourcing, New York, USA, 18-20 July 2023

Home Textiles Sourcing Expo is a one stop sourcing venue for manufacturers, retailers, jobbers, converters, contract specifiers and designers where they can locate new fabrics and products for their latest collections. As a long-term joint venture partnership between Messe Frankfurt & CCPIT-TEX and as one of the largest events in North America to focus solely on textiles and finished soft goods for all home applications.

Council participated in Home Textiles Sourcing with 13-member exporting companies under financial assistance from Market Access Initiative Scheme, Department of Commerce.

The Indian Pavilion was inaugurated by **H. E. Mr. Taranjit Singh Sandhu, Ambassador, Embassy of India, Washington DC, USA** accompanied with Shri Randhir Jaiswal, Consul General of India, New York with ribbon cutting at the event on 18.07.2023 and released the Fair catalogue of HEPC and Texprocil. The Ambassador and Consul General visited Indian Pavilion and interacted with the individual Exhibitors who displayed their product at the pavilion put up by HEPC. The Consul General informed that Indian textile companies have on offer a wide range of world class products, in particular climate-smart, organic, and carbon neutral options & expands the trade.

As per the feedback received from HEPC participants, business enquiries worth Rs.4.24 crores were generated. Totally 105 buyer visits have been received by all member exporters.

The Council was represented by Shri P. Gopalakrishnan, Chairman and Dr. M. Sundar, Joint Director, HEPC.

2. India Fashion & Lifestyle Show, Osaka, Japan, 25-27 July 2023

HEPC organised the participation of member exporters in India Fashion & Lifestyle Show in Osaka, Japan from July 25-27, 2023. It was an exclusive Business Matching Event, which provided opportunities to Indian exporters to showcase their products, and supply capabilities of value-added products with special emphasis on the products designed to suit Japanese fashion & lifestyle trends and requirements.

The event was organised by Japan India Industry Promotion Association (JIIPA), a non-profit organization in Japan organised this event in Japan to Promote India's Textile Trade to capture a respectable share of Japan's textile market.

HEPC participated in this event with financial assistance under Market Access Initiative scheme of Ministry of Commerce & Industry, Govt of India providing opportunities for participation of 30 Member Exporters and a central promotion stall was set-up to distribute promotional materials.

Mr. Nikhilesh Giri, Consul General, Consulate General of India, Osaka-Kobe assured all support to expand business in Japan, and visited stands of HEPC's member exhibitors and interacted with their representatives. He appreciated the efforts taken by HEPC and the wide-range of products showcased by them, and wished them good business at the fair.

A networking meet was organized by the Consulate General of India in Osaka with a participation of the Consul General of India in Osaka, officials of HEPC, FIEO, representatives of Trade Chamber of Commerce and exhibitors.

The participants under the aegis of HEPC reported that they had 296 buyer visits in total and secured spot orders worth Rs. 1.00 crore & trade enquiries Rs. 12.04 crore.

The Council was represented by Shri. P. Gopalakrishnan Chairman, Shri. N. Sreedhar, Executive Director and Shri P. Rangasamy, Joint Director, HEPC.

3. WHO'S NEXT, Paris, France, 2-4 Sept. 2023

WHO'S NEXT is the leading fashion trade show in Europe organised twice a year in January and September at the Porte de Versailles in Paris. For more than 20 years, WHO'S NEXT has aimed to help designers succeed. From young designers to well-established brands, and from urban labels to craftsmen. Presenting the new collections of Ready-to-Wear, Accessories, Beauty and Lifestyle brands to fashion industry professionals, Who's Next is mainly aimed at buyers from all over the world. Agents, journalists, buying offices, stylists, schools and trend forecasters all meet at this leading industry event, to discover the new trends of the sector. Who's Next welcomes around 1,200 French and International brands to the Porte de Versailles Exhibition Center in Paris. With over 40,000 visitors in each edition, it is an unmissable meeting place for buyers and designers.

Council organised the participation of 22 member exporters in the September edition held in Paris during 2-4, September 2023. The event participation was organised by the Council availing financial assistance under Market Access Initiative scheme of Ministry of Commerce & Industry, Govt. of India.

The event was inaugurated by **H.E. Mr. Jawed Ashraf, Ambassador of India in Paris** by a ribbon cutting ceremony at the HEPC pavilion in the presence of Mr. N. Sreedhar, Executive Director, HEPC, the officials of Embassy of India and Indian exhibitors. The visiting dignitary also released the exhibitor's catalogue brought out by HEPC exclusively for the event. Subsequently, the Ambassador interacted with the exhibitors by visiting their booths.

In total, the exhibitors under the aegis of HEPC had about 500 trade visitors and reported that they secured spot order of Rs.5.35 crore and business enquiries of Rs.51.95 crore.

HEPC's participation the event was represented by Mr. N. Sreedhar, Executive Director and Mr. P. Rangasamy, Joint Director (Export Promotion), HEPC.

4. Hometextile & Design, Moscow, Russia, 19-21 Sept. 2023

Hometextile & Design is the only specialized trade fair for home and contract textiles in Russia. Hometextile & Design is more than an exhibition: dozens of lectures, forums and workshops with the most up-to-date information for professional audience, including designers and architects, hoteliers and restaurateurs. This year Hometextile & Design (formerly Heimtextil Russia) was held in a new concept and was thematically divided into 3 large blocks namely Homedesign, Hometextile, Hometex collection. Home Design united the segments of interior and upholstery fabrics, window decoration, wallpaper, paints, carpets, designer furniture and home accessories.

Council participated for the second time in Hometextile & Design with 17 member exporters under financial assistance from National Handloom Development Programme (NHDP) under Ministry of Textiles.

The event was inaugurated by **Ms Gina Uika, Deputy Chief Mission, Embassy of India, Russia** by a ribbon cutting ceremony at the HEPC pavilion in the presence of Shri M. Sundar, Joint Director, HEPC, the officials of Embassy of India and Indian exhibitors. The visiting dignitary also released the exhibitor's catalogue brought out by HEPC exclusively for the event. Subsequently, the Ambassador interacted with the exhibitors by visiting their booths.

Exhibitors under the aegis of HEPC had about 582 trade visitors and reported spot order of Rs. 6.26 crore and business enquiries of Rs.20.69 crore.

The Council was represented by Dr. M. Sundar, Joint Director, HEPC.

5. Global Sourcing Expo, Melbourne, Australia, 21-23 Nov. 2023

The Global Sourcing Expo provides a unique opportunity to meet with clothing manufactures from across the globe including China, India, Turkey, Indonesia, Bangladesh, Japan, South Africa. It brings together industry professionals and suppliers from around the world and provides the unique platform for exploring wholesale clothing suppliers and manufactures and establishing direct sourcing connections.

The Global Sourcing Expo is the ideal setting for networking and building relationship with international clothing manufacturers and suppliers. It is also a gateway to vast array of high-quality home-based products that will captivate your customers and set your business apart.

The event was organized under National Handloom Development Programme of O/o. Development Commissioner (Handlooms), Ministry of Textiles, Govt. of India.

HEPC is participating regularly in Global Sourcing Expo for more than 10 years. HEPC was allotted total space of 198 sq. mtrs. (20 member participants + Council's booth). The participants displayed hometextile made ups, Kitchen Linen, Living Linen, knitted Bedding, Quilts, Ladies Fashion Wear, Shopping Bag, Rugs, Towels, Throws.

Dr. Sushil Kumar, Consul General of India in Melbourne inaugurated India Pavilion in the presence of Shri Rohit Kansal, Additional Secretary, Ministry of Textiles, and other official representatives from HEPC, FIEO, AEPC, TEXPROCIL and WWPEC. The Consul General visited the Indian exhibitors at the event and interacted with them.

As per their feedback, the participants had around 200 visitors and spot order worth Rs.2.40 crore and business enquiries worth Rs.5.07 crore were generated.

The Council was represented by Shri P. Gopalakrishnan, Chairman, Shri N. Sreedhar, Executive Director, and Mr. S. Johnson Samuel, Assistant Director, HEPC.

6. International Apparel and Textile Show, UAE, 27-29 Nov. 2023

International Apparel and Textile Fair (IATF) is UAE's premier platform for sourcing apparel, Fashion Fabrics, Prints, Clothing Accessories, Home Textiles, Footwear, Handbags, Jute & Leather Products. IATF in its 16th Edition showcased Autumn - Winter collections & Spring- Summer highlights. With over 450 + exhibitors, the fair aims to expand with each event becoming a major influence in the MENA REGIONS's FASHION-TRADE INDUSTRY. The fair attracts a wide range of textile mills, accessories/trim suppliers, print designers, and major foot- wear manufacturers. Exhibitors are mainly from Turkey, Hong Kong, China, India, Poland, Italy, Sri Lanka, UK, Spain, Egypt, Japan, Belarus, Germany, Australia and more.

Council participated in International Apparel & Textile Fair, 27-29, November, 2023 held at World Trade Centre, Dubai with the participation of 20 exhibitors from various places of India under the National Handloom Development Programme of O/o. Development Commissioner (Handlooms), Ministry of Textiles, Govt. of India.

The India Pavilion was formally inaugurated on first day evening by **Shri K. Kalimuthu, Consul, (Economic, Trade & Commerce), O/o. Consulate General of India, Dubai** in presence of Chairman WWPEC & Chairman Fair, AEPC & Officials of HEPC, PEDXCIL & others. After the inauguration Consul, interacted with our member participants. Consul appreciated the quality of products displayed by the HEPC member participants in the event.

As per feedback of the participants 282 Trade Visitors visited the fair and received Spot order of Rs.1.40 Crore & Enquiry Generated Rs.1.70 Crore during the event.

The event was coordinated on-site by the Shri Chandrakant D More, Sr. Executive, HEPC.

7. Home Tabel Deco Fair, Seoul, South Korea, 7-10 Dec. 2023

HOME·TABLE DECO FAIR brings the latest premium home styling trends to the show floor and offers inspiring ideas. Every year, this event is considered one of the most anticipated and important events to participate in, among many enthusiasts and professionals in the decoration and lifestyle industry in Korea. HOME·TABLE DECO FAIR features a curated selection of influential furniture, interior brands, and every single corner of one's lifestyle. The event is organised by Reed K. Fairs.

HEPC as a market diversification initiative took part in the event for the first time availing financial grant under Market Access Initiative scheme of Ministry of Commerce & Industry, Government of India.

The India pavilion was inaugurated by **Shri. Nishi Kant Singh, Deputy Chief of Mission, Embassy of India in Seoul**. The Deputy Chief of Mission released the exhibitors' catalogue brought out by the Council and also interacted with the exhibitors.

Coinciding the Council's participation in the event, a Road show on Bharat Tex was organised by the Council at the Business Lounge Exhibition of Convention Center (COEX, Seoul, S.Korea) on 8th December 2023 and the same was presided over by Shri. Nishi Kant Singh, Deputy Chief of Mission, Embassy of India in Seoul. Shri. P. Arjuna, Executive Committee Member of the Council welcomed the participants. Shri. Nishi Kant Singh, Deputy Chief of Mission delivered the key note address highlighting the opportunities available at Bharat Tex for Korean textile importers to explore the Indian textile market. Shri. P. Rangasamy, Joint Director (Export Promotion), HEPC presented on the objectives, features of Bharat tex and the buyer package being extended for the trade visitors. The programme ended with vote of thanks by Shri. M. Thirumurthy Executive Committee Member of HEPC followed by a High Tea.

The exhibitors reported that they had a total of 246 trade visitors which fetched a business outcome of spot order worth Rs.1.86 crore and trade enquiries worth Rs.5.54 crore.

Heimtextil is the industry's most important global event for interior textiles, interior design and interior trends. Heimtextil offers a wide range of home textiles from bath, bed, and table textiles products for windows, floors, walls, sun protection and upholstery.

Heimtextil 2024 ended with 46,000 buyers from around 130 nations took advantage of the opportunity to participate in the global textile market – from upholstery and decorative fabrics, bed and bathroom textiles, mattresses, functional textiles and carpets to wallpapers, outdoor fabrics, artificial leather, curtains, fibres, yarns, sleeping systems and decorative cushions. This edition recorded a plus in visitor numbers and with 2838 exhibitors from 60 nations with 25 per cent growth increase in exhibitor numbers compared to the previous year's event.

The 4 day event which was inaugurated on 26th February, 2024 by the Hon'ble Prime Minister, Shri Narendra Modi at Bharat Mandapam witnessed an overwhelming response not just from Indian, but also global players including top brands and retailers.

Organised by a consortium of 11 Textile Export Promotion Councils and supported by the Ministry of textiles and Ministry of Commerce & Industry, Govt. of India , Bharat Tex 2024 focused on the entire textile value chain from Farm to Fashion, emphasising trade, investment, and sustainability. The event was hosted at Bharat Mandapam and Yashobhoomi, showcasing nearly 2 million square feet of exhibition space. With over 3,500 exhibitors, 3,000 buyers from 111 countries, and more than one lakh trade visitors, the event highlighted the immense potential of India's textile sector on the global stage.

Union Minister for Textiles, Consumer Affairs, Food and Public Distribution and Commerce & Industry, Shri Piyush Goyal chaired the CEO roundtable which deliberated on growth prospects of the Textile Sector. NOTES ON ACCOUNTS

1. Corporate Information

HANDLOOM EXPORT PROMOTION COUNCIL is a Section 25 Company domiciled in India and incorporated under the Companies Act, 1956 - Section 8 of Companies Act 2013. The Company is engaged in the business of support, protect, maintain, increase and promote the export of Indian handloom fabrics.

2. Significant Accounting Policies:

2.01. Basis of preparation

These financial statements have been prepared in accordance with the Generally Accepted Accounting Principles in India, on the basis of going concern under the historical cost convention and also on accrual basis. These financial statements comply, in all material aspects, with the provisions of the Companies Act, 2013 (to the extent notified) read with the rule 7 of the Companies (Accounts) Rules 2014.

All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria set out in the Schedule III to the Companies Act, 2013. Based on the nature of services and the time between the completion of services and their realization in cash and cash equivalents, the Company has ascertained its operating cycle as less than 12 months for the purpose of current and more than 12 months as noncurrent classification of assets and liabilities.

The accounting policies adopted in the preparation of financial statements are consistent with those of previous year.

2.02 Use of Estimates

The preparation of financial statements in conformity with Indian GAAP requires the management to make judgments, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities and the disclosure of contingent liabilities, as at the date of financial statements and reported amounts of revenue and expenses during the reporting period. Such estimates are on reasonable and prudent basis taking into account all available information; actual results could differ from estimates. Differences on account of revision of estimates, actual outcome and existing estimates are recognised prospectively once results are known/ materialized in accordance with the requirements of the respective accounting standard, as may be applicable.

2.03 Property, Plant & Equipment

Property, Plant & Equipment is stated at cost, net of accumulated depreciation and accumulated impairment losses or gains, if any. The cost comprises purchase price, non-refundable taxes, borrowing costs (if capitalization criteria are met) and directly attributable cost of bringing the asset to its present location and condition for the intended use. Any trade discounts and rebates are deducted in arriving at the purchase price.

Subsequent expenditure related to an item of fixed asset is added to its book value only if it increases the future benefits from the existing asset beyond its previously assessed standard of performance. All other expenses on existing fixed assets, including day-to-day repair and maintenance expenditure and cost of replacing parts, are charged to the statement of profit and loss for the period during which such expenses are incurred.

Gains or losses arising from derecognition of fixed assets are measured as the difference between the net disposal proceeds and the carrying amount of the asset and are recognized in the statement of profit and loss when the asset is derecognized.

2.04 Depreciation on Tangible Fixed Assets

Depreciation on tangible fixed assets is provided on written down value method, at the rates and manner prescribed in part C of Schedule II to the Companies Act, 2013.

2.05 Segment Reporting:

The company is principally engaged in the business of providing services to its members which is considered to be the only reportable segment as per the Accounting Standard 17 "Segment Reporting" issued under the Companies Accounting Standard Rule 2006. As the company operates only in one geographical segment, disclosure under geographical segment is not applicable.

2.06 Revenue recognition

Revenue is recognized to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured. The following specific recognition criteria must also be met before revenue is recognized.

(i) Revenue from operations:

The revenue from the members and Grant received is recognized on receipt basis.

(ii) Other Income:

Revenue is recognized with respect to other income on accrual basis. Amenities Receipts is recognized on receipt basis.

2.07 Employee Benefits:

a. Defined Benefit/contribution plan:

The company operates a defined benefit plan for its employees i.e. Gratuity Liability covering all the employees. Provision for Gratuity is made on the norms of the Company on undiscounted basis. The Provision for Gratuity has not transferred to the Gratuity Trust maintained by the Company.

Company contribution to Provident Fund is determined under the relevant schemes and or statute and charged to the statement of Profit & Loss in the period when the contributions are due.

b. Short Term Employee Benefits:

All employee benefits payable wholly within twelve months of rendering services are classified as short term employee benefits. Benefits such as salaries, bonus Ex-gratia, leave travel allowance, reimbursement of medical expenses are recognized in the period in which the employee renders the related services.

2.08 Income tax:

The current tax has not been determined on income for the year chargeable to tax as council is registered under Sec 12A of Income Tax Act, 1961. Deferred tax is not recognized.

2.09 Provisions:

A provision is recognized when the company has a present obligation as a result of past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. Provisions are not discounted to their present value and are determined based on the best estimate required to settle the obligation at the reporting date. These estimates are reviewed at each reporting date and adjusted to reflect the current best estimates.

Provisions involving substantial degree of estimation in measurement are recognized when there is a present obligation as a result of past events and it is probable that there will be an outflow of resources.

2.10 Contingent liabilities:

Contingent Liability is not provided in the books of accounts. The Income tax Department has raised demands against the Council as detailed below:

The income tax refunds for the assessment years 2021-22 & 2022-23 were also adjusted against the demand outstanding.

The Assessing Officer of Income Tax Department has disallowed the expenses incurred outside India and not eligible for exemption u/s 11. The council appealed against the order before the CIT (A) and it was allowed subsequently, but the Department has filed an appeal before the Hon'ble ITAT "C" bench, Chennai and it was remitted back to AO for fresh examination.

The AO after examining the expenses incurred outside India is not in conform with the provisions of section 11(1)(a) to 11(1)(c) of the Income Tax Act, 1961 and brought to Tax.

The council again made an appeal with CIT (A) and is still pending.

2.12 Government Grant:

Grant is accounted to confirm AS-12 issued by ICAI.

Grants in the nature of revenue with specific conditions for utilization is recognized as income, to the extent actually spent during the financial year and amount not utilized is carried as current liability.

Expenses incurred against sanctioned grants eligible as per prevailing Government policy, with reasonable certainty to be released, are shown as recoverable where grants are yet to be disbursed.

Excess or Short receipt of Grant (if any) as against recoverable amount is recognized in the Income & Expenditure account in the year of its actual settlement.

2.13 GST:

The Management is collecting GST on Membership fees and other service charges remitting to GST department. The Ineligible Input Credit and the Common Input Credit on Exempted Turnover is not reconciled in the Financials and the GST Portal.

2.14 Lease Rent:

Assets subject to operating leases are included in fixed assets. Lease income is recognized in the Statement of Income & Expenditure account.

2.15 Cash Flow Statement

Cash Flow statement is reported using the indirect method, whereby profit/loss before extraordinary items /exceptional items and tax is adjusted for the effects of transactions of non-cash nature and any deferrals or accruals of past or future cash receipt or payments. The cash flows from operating, investing and financing activities of the company are segregated based on available information including taxes paid relating to these activities.

2.16 Remuneration to Auditor:

(Rs. in Lakhs)
